# USA JUDO GAMES STAFF SELECTION PROCEDURES 2024 Olympic Games Men and Women 31 October 2022

These procedures provide for selection of USA Judo's **Games Staff** [**Team Leader, Coach(es),** and/or Additional Officials]] for the 2024 Olympic Games. However, accreditation allocation is not guaranteed and will be based on final USOPC credential allocation and overall team size. Responsibility of payment for allocated accreditations will be determined by the USOPC and the NGB/PSO.

1. List of specific Games Staff position(s) that the NGB/PSO is requesting:

Games Staff Role	Responsibility	
Team Leader	Serve as primary point of contact and liaison between the USOPC and USA Judo before, during and after the Games.	
Coach	Prepare athletes/teams for success on the field of play.	
High Performance Director/Coach	Provide technical, tactical and team preparation expertise.	
Assistant Coach	Provide technical, tactical and team preparation expertise as input for the Head Coach.	

2. USA Judo's criteria for the above-listed Games Staff position(s) (attach a job description, if any):

# USA Judo's Games Staff must:

- 2.1. Undergo a background screen in accordance with the current <u>USOPC Games</u>
  <u>Background Check Policy & Procedures</u> prior to nomination.
  - 2.1.1. Should a nominee experience any event between the time the background check is conducted and the relevant Games that may change his/her background check status, the nominee must inform the NGB/PSO and/or the USOPC.
- 2.2. Possess a valid passport that does not expire until at least six months after the conclusion of the Games.
- 2.3. Have the ability to work effectively with the USOPC.
- 2.4. Have strong administrative, communication and organizational capabilities/skills as applicable for the Games Staff role.
- 2.5. Be responsible for Team's adherence to all rules regarding personal conduct at the Games.
- 2.6. Fulfill all duties and requirements of the USOPC including attendance at USOPC Games related meetings, as applicable.
- 2.7. Be available for entire duration of the Games, if requested.
- 2.8. Have NGB/PSO's approval prior to making any financial decisions regarding the Team.

- 2.9. Possess high level, specific technical and tactical knowledge of the sport as needed for the Games Staff role.
- 2.10. Have thorough knowledge and understanding of the IF rules and regulations governing the sport as needed for the specific role.
- 2.11. Demonstrate ability to establish harmonious relationships with athletes and other Team personnel.
- 2.12. Be in good health and able to withstand the physical rigors of traveling with and working with the Team.
- 2.13. Be a currently employed staff member or contractor of the NGB/PSO.
- 2.14. Be listed on NGB's/PSO's Long List.
- 2.15. Successfully complete all Games Registration requirements by stated deadlines.
- 2.16. Participate in the appropriate anti-doping training as required for the Games Staff role by stated deadline.
- 2.17. Successfully complete the appropriate U.S. Center for SafeSport's online training module(s) by stated deadline.

In addition, Coach(es) (Head Coach, Asst. Coach) must:

- 2.18. Possess a high level of specific technical and tactical knowledge of the sport.
- 2.19. Be a member in good standing with USA Judo.
- 2.20. Be a current USA Judo "International A" level certified coach.
- 2.21. Have experience and proven ability coaching teams at the national and international levels.
- 2.22. Have a proven record of performance with USA Judo.
- 2.23. Be a member of USA Judo's International Coaching Pool.

In addition, High Performance Director must:

- 2.24. Be employed as the USA Judo High Performance Director.
- 3. Intended method of identifying the pool and selecting the candidates to be considered for the Games Staff position(s):

USA Judo will not solicit applications for the Games Staff position(s) listed above as they will be filled by current USA Judo employees and/or contractors.

### Team Leader:

The Team Leader will be selected from the USA Judo International Manager Pool. The International Manager Pool will consist of a working list of managers who have been traveling with the National Team throughout the 2024 qualification process. Candidates will be recommended by the USA Judo High Performance Committee based on who best meets the criteria listed in Section 2.

Head and Assistant Coach(es):

The Head and Assistant Coach(es) will be selected from the USA Judo International Coaching Pool. Candidates will be recommended by the USA Judo High Performance Committee based on who best meets the criteria listed in Section 2.

High Performance Director/Coach:

The current High Performance Director will serve in this role provided they meet the criteria listed in Section 2.

# 4. Removal of Games Staff:

An individual who is nominated to the above-listed Games Staff position(s) by NGB/PSO may be removed as a nominee for any of the following reasons, as determined by NGB/PSO.

- 4.1. Voluntary withdrawal. Games Staff nominee must submit a written letter to the NGB/PSO Executive Director/CEO/President.
- 4.2. Injury or illness as certified by a physician (or medical staff) approved by the NGB/PSO. If the individual refuses verification of his/her illness or injury by a physician (or medical staff) approved by the NGB/PSO, his/her injury will be assumed to be disabling and he/she may be removed.
- 4.3. Inability to perform the duties required.
- 4.4. Violation of the USA Judo's Code of Conduct ( <a href="https://www.teamusa.org/USA-Judo/About-Us/Governance/USA-Judo-Policies">https://www.teamusa.org/USA-Judo/About-Us/Governance/USA-Judo-Policies</a>).
- 4.5. No longer able to meet the required criteria in Section 2 at the time of the Games.

Once the Games Staff nomination(s) is accepted by the USOPC, the USOPC has jurisdiction over the Games Staff, at which time, in addition to any applicable NGB/PSO Code of Conduct, the USOPC's Games Forms apply. The USOPC's Games Forms are available as part of Games Registration prior to the respective Games.

# 5. Replacement of Games Staff:

In the event that the Nominated Games Staff member is unable to perform the duties of the position(s) for injury, illness, Code of Conduct violation or any other unforeseen circumstances that would result in the need to replace him/her, the replacement candidate must meet all of the applicable criteria listed in Section 2 above.

6. Group/committee that will make the final approval of the Games Staff position(s):

The USA Judo High Performance Committee will make recommendations to the USA Judo CEO for the team leader and head and assistant coach positions. The USA Judo CEO, will make the final approval.

The USA Judo CEO will make the final approval for the High Performance Director/Coach role.

## 7. Conflict of Interest:

All individuals involved in the selection process (see Section 6) must comply with the NGB/PSO's conflict of interest policy, to include completing and submitting a disclosure form for review by the NGB/PSO's Ethics Committee prior to beginning the selection process.

An individual involved in the selection process who has an actual, possible, or perceived conflict of interest must disclose it to the NGB/PSO's Ethics Committee prior to the start of the selection process. The NGB/PSO's Ethics Committee shall review the disclosure and determine the individual's level of involvement (e.g., whether he/she must recuse him or herself from the review process and/or voting).

Any recused individual shall be replaced in accordance with the NGB/PSO committee appointment process.

# 8. Date of Nomination:

Nominations of Games Staff, including the names of any replacements, will be submitted to the USOPC on or before:

Non-Athlete dependent staff: Team Leader, High Performance Director – May 1, 2024

Athlete dependent staff members: Head and Assistant Coaches – June 25, 2024 or July 2, 2024. Note: Nomination for athletes & athlete-dependent staff is on or before June 25, 2024. However, if a fight-off is required (more than one athlete ranked in the top 17 on the IJF World Ranking as of June 25, 2024), nomination for athlete-dependent staff will be on or before July 2, 2024.
